**C. Richard Kramlich** is Co-Founder of New Enterprise Associates (NEA) and is currently Chairman of the NEA Management Company. He was Managing General Partner of the firm through NEA VII when he turned the reins over and became a General Partner. A legend in Silicon Valley, Kramlich was one of the first American venture capitalists to invest in China and was recently featured in the documentary film *Something Ventured*.

**Amory Lovins** is Co-Founder, Chairman, and Chief Scientist of Rocky Mountain Institute (RMI), an independent, apolitical, non-profit think-and-do tank that drives the efficient and restorative use of resources. He is the author of the groundbreaking book, *Reinventing Fire*, and will soon be opening an RMI center in China.

**Sidney Rittenberg** lived in China from 1944 to 1979 and has known every Chinese leader since Mao Zedong. He was the first American admitted to the Chinese Communist Party and served as lead translator for the English language edition of Mao Zedong's *Selected Works*. Rittenberg subsequently spent a total of 16 years in solitary confinement under suspicion of serving as an American spy. He was recently the subject of the documentary film, *The Revolutionary*, which chronicles his experiences in China.

# An Extraordinary Burst of Activity in Northern California



Even for ASNC's staff, this has been an extremely productive four months – and we have more to come!

As we reported in the last issue of the newsletter, we launched the Asia Society/Rhodium Group study *Chinese Direct Investment in California* last fall, with release events in San Francisco, Los Angeles, Shanghai, and Beijing. The public and media response has been overwhelming, so much so that we have decided to continue the project with new research and events for 2013.

In May, we will host, with the San Jose/Silicon Valley Business Journal, an event that will focus on Chinese investment in high tech sectors in Silicon Valley – one of the fastest moving trends the report found. For June, we are organizing a major program on the surge of Chinese investment in California real estate, both residential and commercial. And for later in the year, we are beginning to make plans for a follow-on study that will update our 2012 findings as well as drilling into some of the sectors that are showing the most activity, and promise, today.

In February 2013, we held our fifth Pacific Cities Sustainability (PCSI) Forum, which is our first in Asia. Entitled "Tomorrow's City Today," the invitation-only event was designed to bring together urban planners, academics, business leaders, architects, policy makers, and NGOs to interact and discuss best practices in an informal environment. As important as these cross-sector and cross-border exchanges are, it still surprises me that they do not happen very often, and they lie at the very heart of the Asia Society's mission: convening, connecting, and catalyzing change.

### Chairmens' Corner

One of the reasons that we came to Asia Society is our strong belief that there is a real appetite in Northern California for the rich diversity and complexity of Asia. Though our backgrounds as Co-Chairmen are very different, we have always thought that discussion and dialogue—not to mention visual arts—are the best way to build and sustain an ongoing fascination in all things relating to Asia. The ASNC team has this year put together a great palette of programs—from hosting over 50 young Chinese entrepreneurs for a program on innovation in China to looking at the impact of the rise of Asia with Kishore Mahbubani, from sustainable cities on the Pacific Rim to inbound direct investment from China to California.

All these streams come together May 17, when the Asia Society holds its 10th Annual Dinner. This year's speakers are renowned for their contributions in three fields:

Policy—**Amory Lovins**, Co-Founder, Chairman and Chief Scientist at The Rocky Mountain Institute, one of the leading sustainability "Think and Do Tanks" in the world.

Business—**C. Richard Kramlich**, Chairman and Co-Founder, New Enterprise Associates, one of the first and premier venture capital firms in Silicon Valley. Dick is also a member of the Northern California Advisory Board. The Forum was produced with the very active participation of the Urban Land Institute, our partner for PCSI. Special thanks to our sponsors and to our Sustainability Program Manager, Emily Peckenham, who took a complex program to a successful conclusion.

As with our project on Chinese investment in California, PCSI is an ongoing initiative and our momentum continues to build. In the coming months, watch for new multi-media content on our website and follow-on events in California. We are also beginning to plan for next year's Forum, which will also take place in Asia.

# Tomorrow's City Today: PCSI Annual Forum Held in Hong Kong

The Asia Society has just returned from Hong Kong, the host city of the inaugural Pacific Cities Sustainability Initiative (PCSI) Forum. Entitled "Tomorrow's City Today," the Forum was held at Asia Society's new Hong Kong Center and brought over 100 experts from around the Pacific Rim on February 18-20 for interactive expert discussions about the future of cities. The Forum was organized in partnership with the Urban Land Institute (ULI), a global nonprofit education and research institute whose mission is to provide leadership in the responsible use of land and in creating and sustaining thriving communities worldwide. The gathering kicked off with a series of site visits in Hong Kong, where participants explored real-world approaches to sustainability including Hysan Place, the first building in Hong Kong to receive LEED platinum certification. The Forum then opened with a public program headlined by Hong Kong's Under Secretary for the Environment, **Christine Loh**, and moderated by **Roger Platt** of the U.S. Green Building Council.

Over the next two days, Forum participants engaged in an interactive dialogue where best practices were shared, case studies were presented, and new developments in urban sustainability were analyzed. The invitation-only Forum involved leading figures drawn from multiple sectors—including government, private sector, civil society, and academia—for an interdisciplinary dialogue addressing the challenges of population growth, limited natural resources, and environmental degradation in cities across the Pacific Rim. Highlights included keynotes by **Chandran Nair** of the Global Institute For Tomorrow and leading Singaporean architect **Thai Ker Liu**. Overall, speakers at this year's Forum underscored the rapid consumption patterns taking place in cities and the need for integrating sustainability and livability into today's urban planning.

### Young Entrepreneurs Reshaping the Face of China's Economy

ASNC hosted a delegation of over 50 Chinese entrepreneurs, all graduates of the **Chinese European International Business School** (**CEIBS**), the top-ranked Chinese business school, on January 23. Joining the group were two of the U.S.'s most celebrated investors and entrepreneurs, **Jack Wadsworth** and **William Draper**.

The focus of the evening was innovation, entrepreneurs, and the future of the Chinese economy. Everyone on the panel was bullish about the future of China's economy and the ever-expanding leadership of privatesector entrepreneurs. If current patterns continue, stereotypes of Chinese businesses as imitators, not innovators, will disappear fast. Wadsworth and Draper shared the delegation's optimism, and both foresee China becoming an innovation-based economy within decades if not years.

# Immigration and the Future of Silicon Valley

On January 31, leading experts gathered for an event as part of ASNC's Asian America Now program series to discuss Asian immigrants and their impact on the Silicon Valley economy amidst the heated nationwide debate on immigration reform. Moderated by **Carl Bass**, President and CEO of Autodesk, the panel featured **Vivek Wadhwa**, author of *The Immigrant Exodus: Why America is Losing the Global Race to Capture Entrepreneurial Talent*; UC Berkeley Professor **Annalee Saxenian**; and Stanford Law School's **Dan Siciliano**.

Panelists agreed that immigrants have played a critical role in founding tech companies and creating jobs in the Valley, but post-9/11 tightening has had a chilling effect. They argued that Silicon Valley's success can be exported, if not duplicated, and other countries can benefit by connecting with the Valley in the globalized world. But the broken U.S. immigration system needs to be fixed for these gains to continue.

# Transformation of U.S.—Asia Relations

As China's economy and geopolitical influence grow over the next decade, the U.S. must adapt its foreign policy accordingly. On February 26, ASNC hosted **Kishore Mahbubani**, who served as Singapore's Ambassador to the UN, and Asia expert and UC Berkeley professor **Steven Vogel** for a discussion moderated by the Asia Society's Vice President for Global Programs, **N. Bruce Pickering.** 

In town to promote his new book, *The Great Convergence: Asia, the West, and the Logic of One World*, Mahbubani predicted that in the next seven years Asia's middle class will grow from 500 million to 1.75 billion and China will overtake the U.S. as the world's largest economy. These shifts are not necessarily negative for the U.S., he explained, as growing "convergence" with Asia may aid Americans economically.
