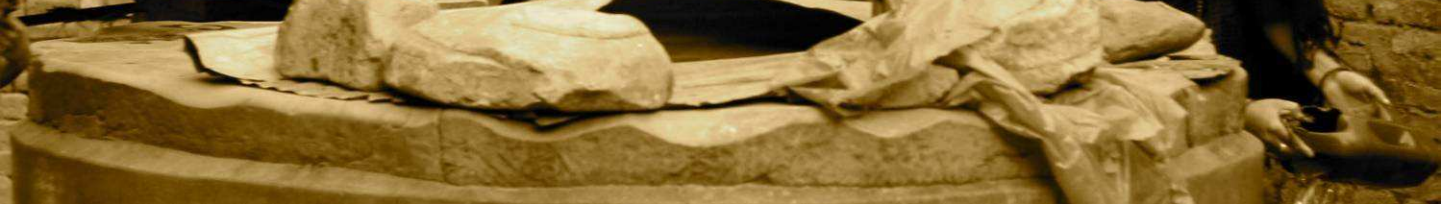


# Asia 21 Young Leaders Initiative



## 2010 PUBLIC SERVICE AWARD

We invite you to nominate an organization that deserves to be considered for the Asia Society's Asia 21 Young Leaders Initiative 2010 Public Service Award (PSA). The winning organization will receive not only US\$10,000, but also the ongoing support of the Asia 21 Class of 2010 Fellows. Selection criteria and an application form are attached.



## **THE AWARD:**

The Asia Society's "Asia 21 Young Leaders Initiative" brings together dynamic young leaders from across the Asia-Pacific region and the United States. Asia 21 Class of 2010 Fellows, a core group of leaders from the Asia Society, are pleased to announce the launch of the Asia 21 Young Leaders Initiative 2010 Public Service Award (PSA). The award recognizes an organization that serves underprivileged social and economic groups, communities and the public in the Asia-Pacific region.

The goals of the Public Service Award are as follows:

- (a) Recognize the achievements of a small to medium-sized organization engaged in public service in the Asia-Pacific region
- (b) Provide a grant to support the activities of the organization
- (c) Provide ongoing support for the organization through the assistance of the 2010 Asia 21 Class of Fellows
- (d) Replicate successful activities of the organization in other countries

The Award consists of US\$10,000 along with the continued active support of the Asia 21 Class of 2010 Fellows in providing the selected public service organization with access to the Fellows' network for program development as well as in helping to replicate the models of successful projects. This additional in-kind aid will help position the award-winning organization with the tools to expand to a higher level of service and to other regions around Asia.

## **SELECTION CRITERIA FOR ORGANIZATIONS:**

An organization should meet the following eligibility criteria:

### ***ESSENTIAL CRITERIA***

All organizations applying for this award must:

- be nominated by an Asia 21 Fellow or Delegate of a past Asia 21 Young Leaders' Summit
- be based in the Asia-Pacific region and conduct activities in the Asia-Pacific region
- be willing to accept ongoing support from the Asia 21 Class of 2010 Fellows
- gain permission to accept funds from the United States of America
- demonstrate positive impact from their work at the time of submission of their application
- have an annual budget of less than US\$ 3 million
- have a transparent accounting process for finances

### ***DESIRABLE CRITERIA***

It is highly desirable that a successful organization:

- conduct work that is innovative and sustainable over the long-term
- conduct work with specific and measurable impact that can be tracked over time
- have a clear mission statement and focus
- come from a different country than that of the winner from previous years\*
- conduct work that meets the needs of a specific underprivileged group or community
- conduct work that has the potential to grow and be extended to other countries in the Asia-Pacific region

Organizations with smaller annual budgets will be considered favorably during selection.


\* Organizations in Hong Kong (other parts of China are permissible), India, Iran and Nepal were past winners.

### ***Award Selection Committee:***

The Award Selection Committee will consist of the Asia 21 Class of 2010 Fellows and the Asia Society, with technical support from additional organizational partners.

### NOMINATION PROCEDURES:

Current and previous Asia 21 Young Leaders (including both Delegates and Fellows) are invited to nominate one or more organizations for the Asia 21 2010 Public Service Award. The organization should complete the following application form, including the name and year of the Asia 21 Delegate or Fellow.

The application, including the documents described on the following page, should be submitted by email as a **single PDF document**. All nominations should be submitted in English.

### NOMINATION DEADLINE:

Completed nomination, application forms and required information therein must be submitted by **12:00 Midnight, ET on August 23, 2010**.

### SUBMISSION OF NOMINATION FORMS:

Nominations for the Asia 21 2010 PSA should be submitted **by email only** to:

### AWARD CEREMONY:

The Asia Society will cover the cost of a senior representative from the award recipient organization to attend the award presentation ceremony at the Asia Society's Asia 21 Young Leaders Summit in Jakarta, Indonesia, from December 3-5, 2010. The recipient is encouraged to provide a handout or booklet to promote his/her project at the Summit. The Asia 21 2010 PSA Committee will screen a two-minute audio visual presentation of the recipient's work at the Summit if this is available.

### POST-AWARD ACTIVITIES:

The award recipient organization will receive active support from the Asia 21 Class of 2010 Fellows and their networks for one full year. After one year, the award recipient will be expected to report back to the Asia 21 Class of 2010 Fellows.

4. Additional information that supports your application (such as press releases, reports or other data relating to projects mentioned in your application). The additional information should be a maximum of 5 pages. This is not essential to your application. We may request additional information during the review process.

Nominations for the 2010 Public Service Award should be submitted **by email only**. Please scan these documents and include them all in a **single PDF document**. Please endeavor to keep the PDF file to a maximum size of 10MB. You can merge a number of separate PDF documents by using various programs available free on-line.
