The Group intends to actively promote all actions addressed to customers, authorities and interested local communities at reaching the highest environmental protection and conservation standards.

SINOHYDRO will engage regularly, openly and honestly with the people interested in and affected by our operations. We will strive for mutual beneficial incomes.

SINOHYDRO attributes a priority to the following objectives:

- -Adopt all the World Bank's safeguards policies as a minimum standard for SINOHYDRO's operations;
- -Comply with local legislation, international standards, company's requirements and apply the strictest standards wherever possible;
- -Identify and assess the social and environmental impacts of the Group's activities;
- -Prevent and limit the environmental impact of their activities by applying good practices and operation instructions which have as little effect as possible on the environment;
- -Commit to not harming the environment and protecting biodiversity whenever possible.

SINOHYDRO aims at reaching these objectives by:

- -Adopting a set of 'No-go areas' including national parks, World Heritage Listed Areas, habitats of threatened species and internationally listed and protected wetlands;
- -Implementing and developing an environmental management system which complies with the requirements stated by ISO 14001 including:
 - -An environmental impact assessment and implementation plan;
 - -Controls to avoid or mitigate environmental impacts;
 - -Monitoring and reviewing programs to assess the environmental impacts;
 - -Rehabilitation of disturbed areas.
- -Training employees on environmental subjects;
- -Reducing greenhouse gas emission from the full lifecycle of our projects;
- -Ensuring a rational and sustainable use of natural resources;
- -Publish environmental efforts and progress in the implementation of this policy.

All SINOHYDRO employees are directly responsible for applying this policy. This requires all employees to participate and accept responsibilities in order that the objectives are achieved. All personnel involved in the project are required to work towards the success of this policy.
